

Puppy/Dog Reservation Agreement

This agreement ("Agreement"), dated as of	(the "Effective	Date"), i	s between	Heather	Sanders
of SI Dynamics, Inc. dba Red Barn Moyen Poodles ("B	reeder"), and			("I	Buyer").
Buyer agrees to place a \$200 reservation fee ("Reservatio	n Fee") to secur	re a place	for an AK	C poodle	puppy
from Breeder's next litter					

Buyer is placing the reservation for:

- 1. <u>Non-Refundable Reservation Fee</u>. Buyer acknowledges that the Reservation Fee is <u>non-refundable</u> in all circumstances, including but not limited to if Buyer decides s/he does not want their reservation spot or no longer wants a puppy. Upon receipt of the Reservation Fee, Breeder agrees to hold the designated reservation spot marked above for Buyer until it is time to select their puppy. Reservation Fee must be paid within 24 hours of the signing of this Agreement by one the the methods outlined in Section 6 or this Agreement is null and void.
- 2. <u>Buyer Acknowledgements</u>. Buyer further acknowledges and agrees that (a) Breeder cannot control litter sizes, genders, or heat cycles. If the wait time for a puppy exceeds 12 months from Effective Date, then Buyer can elect to forfeit their spot and have their Reservation Fee refunded. (b) the Reservation Fee gives Buyer a designated place, but does not guarantee a puppy of Buyer's gender preference will be available when the litter is born, in which case the Buyer may elect to have the Reservation Fee transferred to the next litter or refunded.
- 3. <u>Selection of Puppies.</u> Buyer will choose in order of the designated reservation spots (i.e. Female Spot 1, Female Spot 2, etc.). Selection dates will be announced at least 5 days in advance. Buyers with reservation spots will have 24 hours to make their selection when it is their turn. Once selection has been made, Buyer agrees to send the \$300 non-refundable Deposit and Deposit Contract within 24 hours by one of the means outlined in Section 6 or their reservation is forfeited.
- 4. <u>Refund at Breeder's Discretion</u>. If Buyer pays the Reservation Fee and then later decides s/he does not want a puppy for any reason, Breeder is not required to refund the Reservation Fee. Breeder may (in its sole discretion) choose to either refund the Reservation Fee or allow the Reservation Fee to be transferred to the next available litter.
- 5. <u>Final Purchase Price</u>. Breeder and Buyer agree that (a) the Reservation Fee and Deposit shall be applied to the final purchase price of the puppy with the remaining balance due before the puppy is picked up; (b) the total purchase price for the puppy with AKC limited/pet registration is \$2500. As part of the limited registration, there will be an unauthorized breeding clause included in the full contract; (c) the foregoing purchase price does not include any delivery or shipping charges.
- 6. Payment Schedule. Reservation Fee is due within 24 hours of the signing of this Agreement. If Reservation Fee is not paid within 24 hours, then Breeder cannot guarantee the designated spot listed above. At the time of puppy selection, the Deposit of \$300 will be due along with the Deposit Contract. The remaining balance of \$2000 is to be paid upon pick-up if paying in cash or at least 24 hours before pick-up/drop-off if paying electronically with Zelle*, GoodDog, or credit card. All payments shall be made in US Dollars and paid to Breeder via Zelle, check (with prior approval), cash, or GoodDog. Buyers paying through GoodDog must add the 6.5% fee to all payments.
- 7. Governing Law. This Agreement, and all matters arising out of or relating to this Agreement, shall be governed by and construed in accordance with the laws of the State of Illinois without regard to the conflicts of laws provisions thereof and any legal action must be brought in the County of Franklin, State of Illinois.
